

Personal Data Protection Principles in EUTIT s.r.o.

Personal Data Processing-related Information

EUTIT s.r.o., with its registered address at Stará Voda 196, 353 01 Stará Voda, ID: 47714930, pays attention to the protection of your personal data. It is important that you know that we process your personal data responsibly, transparently and in compliance with Regulation of the European Parliament and of the Council (EU) 2016/679. You are entitled to ask for information on your recorded personal data and for its correction or deletion if the data has been obtained based on your consent. In the event of automated processing, you have the data portability right and are entitled not to be the subject of a decision predicated solely on such decision-making. If you have any questions and requests relating to the processing of your personal data, do not hesitate to contact us in writing at the Company's registered address.

Personal Data Security

EUTIT s.r.o. pays attention to the security of your personal data. We have taken appropriate technical and organizational measures to sufficiently protect your data with regard to the gravity of its processing. No unauthorized person has access to your personal data and we do not disclose your data to any third parties for processing without your consent, unless we are required to do so pursuant to the laws or unless we protect our legal interests.

Right to Information

It is your right to ask EUTIT s.r.o. what personal data it processes and to what extent and for what purpose. We will provide you with this information free of charge at the latest within 30 days or, in extraordinary situations, within 90 days. We will inform you about the extended time-limit in extraordinary cases in time. If you request the communication of information recorded on your person, we will first need to verify that you are the person to whom the data actually belongs. In your request, please sufficiently identify yourself. If needed, we are entitled to ask for additional information to identify you before we provide you with the personal data processed in relation to you.

We are entitled to reject, stating the reason, any requests for information which is unfounded or unreasonably recurring, which is difficult to obtain (usually from back-up systems, archives, etc.) or, possibly, the obtaining of which requires unreasonable efforts.

Data Portability Right

You are entitled to obtain your personal data we record in a structured, commonly used and machine-readable format. This data may be handed over to another controller at your request.

Data Update; Right to Correction

Since personal data may change over the time (e.g. changed surname), we will be glad if you notify us of a change in your personal data so that we can have data that is current and can avoid possible mistakes. We need to be notified of a change in your personal data in order to be able to duly perform our Controller activity.

This is also associated with your right to correct your personal data recorded on you. If you find out that your personal data is no longer current, you are entitled to ask for its correction.

Objections

If you believe that we are not processing your personal data in compliance with the applicable laws of the Czech Republic and the European Union, you are entitled to raise objections and we will check the legitimacy of your request. At the moment of raising the objections, the processing of your personal data will be limited until it is verified that the objections are justified. Please note that you are entitled to turn with your objections to the processing of your personal data to the respective supervisory authority – Office for Personal Data Protection – at the following address:

Right to Limited Processing

You are entitled to request that the processing of your personal data is limited if you believe that the recorded data is inaccurate or is processed illegally or that we no longer need it for processing purposes.

Right to Deletion

If you have ever provided us with your consent to the processing of your personal data (e.g. e-mail address used in the sending of newsletters), you are entitled to revoke the consent at any time and we are obliged to delete the data processed solely on the basis of your consent. The right of deletion does not relate to data processed within the obligation to perform a contract, for legal reasons or within our legitimate interests. If any of your data is stored in back-up systems which automatically secure the resistance of all our systems and protect data from loss in case of accidents, it is not in our powers to delete this data from such back-up systems, and it is not even technically feasible. Nevertheless, this data is not actively processed in any way and is not intended for further processing.

Website – Protocol Files

If you access our website and browse it, we process the following protocol files and save them on our servers. The information we store includes:

- your IP address
- accessed page of our website
- http reply code
- identification of your browser

We process this information for a period of at most one year and only for the purposes of our legal protection.

Cookies

When you access our website, you are informed that we use technologies to collect information and store it in your equipment by means of cookies. Cookies are small text files we do not send anywhere. You can remove these files from your browser or disable their use completely. Cookies do not collect any of your personal data; however, without them, we cannot ensure a full-fledged functioning of our website.

Analysis and Statistics

We monitor and analyse our website through analytical services. None of the data analysed through this service is your personal data. We use the service to find out the traffic rate of our website, geographical details, and information on your browser and on the operational system from which you access our website. We use this information for marketing purposes, for the purpose of the further improvement of our website and its content, and for legal protection purposes.

Sending News by Email

If you are interested in receiving product offers from EUTIT s.r.o. on the email address communicated to us and you grant us your consent to the use of such email address, we will process it solely for these purposes. EUTIT s.r.o. will not disclose the email address to any third parties. If you decide at any time in the future that you no longer wish to receive emails from EUTIT s.r.o. for this purpose, you can revoke your consent to the processing of your email address [here](#) or in writing to the Company's registered address.
